

General Terms and Conditions of EDRA Media GmbH for visitors to LEGAL REVOLUTION 2024

We are delighted that you are taking part in the LEGAL REVOLUTION! Do you have any questions or other concerns about our GTC? We are here for you at Info@LEGAL-REVOLUTION.com.

To make our GTC easier to understand, we refrain from using more than one gender and try to use gender-neutral terms. Where this is not appropriate, we use the masculine form, e.g. "the visitor". We always mean all genders equally.

These General Terms and Conditions apply to visitors to LEGAL REVOLUTION 2024 (the "Event"), which is organised by EDRA Media GmbH (the "Organiser").

1. Visit to the trade fair and congress

To gain access to the event, visitors must purchase a ticket via the pretix.eu website. When registering, visitors create a profile in which they answer questions about themselves (first and last name, company, position, city, profile picture, etc.) and indicate their main interests. The profile is included in the list of participants and is available to all participants of Legal Revolution 2024 and serves to establish interactive contact and networking between the participants.

1.1 The Organiser may cancel a registration for the event if the registered person does not belong to the visitor groups in accordance with Section 1.2. It may also cancel a registration if there are other objective reasons, for example if the event is cancelled.

1.2 LEGAL REVOLUTION 2024 is a presence congress trade fair for trade visitors. We offer different visitor ticket categories for the visitor groups listed below.

1.2.1 Special tickets: reserved for young professionals (up to the age of 35), students, members of partner organisations, associations, cooperation partners, judicial authorities, ministries of justice and chambers of justice, scientific institutions and universities.

1.2.2 Starter, Professional und Pionier Tickets: reserved for members of law firms, tax consulting and auditing firms, legal departments, compliance departments, tax departments, digitalisation departments, IT departments, HR departments, M&A departments, regulatory departments, alternative legal service providers, notary's offices, insolvency administrations, providers of products and services for law firms and Legal departments (e.g. for legal tech providers and software providers) and for all other visitors for whom no other ticket is reserved.

1.2.3 Student Ticket: reserved for full-time students, doctoral candidates and trainee teachers. The presentation of proof is required.

1.2.4 Press and press accreditation: reserved for members of the press and reporters. The presentation of proof is required.

1.3 Upon request, visitors must prove to us that they belong to one of the visitor groups. If they fail to do so or if the categorisation turns out to be incorrect, we will charge a fee of EUR 200.

1.4 The Organiser reserves the right to refuse admission or to refuse to allow a visitor to remain at the event if the visitor engages in promotional activities at LEGAL REVOLUTION 2024 without being registered as an exhibitor ticket holder, demonstrably exhibits unethical behaviour or uses the communication facilities of LEGAL REVOLUTION 2024 for purposes outside the specialist topics of LEGAL REVOLUTION 2024 and does not comply with the regulations set out in these General Terms and Conditions. The organiser will not reimburse any expenses incurred as a result.

2. Cancellation conditions, transfers and changes

2.1 Tickets may be transferred to another attendee from the same legal entity or a different entity without incurring additional charges. Changes and transfers can and must be carried out independently using the link provided when booking the ticket. No service fee shall apply to any ticket modifications.

2.2 The organiser reserves the right to cancel the event 14 days before the start of the event if fewer than 800 visitors have registered by then. In this case, the visitor will receive a refund of the participation fee already paid or will be rebooked for another event organised by the organiser; the visitor has no further claims. The visitor can check the current number of visitors at any time.

2.3 It is possible that individual lectures, other contents of the event and speakers may change, be replaced or cancelled, whereby the overall character of the event may not be significantly impaired as a result. The organiser does not guarantee the correctness, accuracy and completeness of the content of the event.

3. COVID-19-related cancellation, force majeure

3.1 The organiser reserves the right to cancel the event in whole or in part for reasons related to the COVID-19 virus, for example because it reassesses the risk situation due to COVID-19. The cancellation is deemed to be a withdrawal from the contract(s) between the organiser and the visitor. 3.2 The event may be cancelled for the following reasons, among others: Force majeure such as war, terrorist attacks, natural disasters, riots, strikes, by law or for any other reason for which the organiser is not responsible.

5.2 The sponsors or exhibitors of the event are not deemed to be vicarious agents of the organiser.

5.3 If a visitor causes damage to a third party, he/she is obliged to indemnify the organiser against all claims asserted against it on the basis of such damage.

6. Applicable law and place of jurisdiction

6.1 These contractual conditions are subject to German law.

6.2 Frankfurt am Main is agreed as the place of jurisdiction.
